This contract is valid under the following conditions:

A kitty sold as a pet will arrive to purchaser spayed or neutered.

The deposit of \$350.00 is required for purchase. This is a non-refundable deposit, which means if the purchaser should decide to not continue with the purchase of the kitty, they forfeit their deposit.

The seller guarantees the kitty to be in good health at the time of purchase for a period of 72 hours. Kitty will come with a vet certificate of health. A feline health record will be provided at time of purchase. It will be the responsibility of the purchaser to have the kitty examined by a veterinarian within 72 hours. Within that 72 hour period, if found to be seriously medically deficient, the kitty will have to be tested for Leukemia, Bordetella and FIV before seller will consider taking the kitty back, in the event that this kitty might have been exposed to other animals or the contract is voided, for the safety of the breeders cattery. After 72 hours the buyer is totally responsible for all vet bills. New kitty should be confined to a private room, with plenty of toys and human contact. With no contact with other animals for 2 wks, to avoid stress that could affect the kitty's health.

You will have a three year health guarantee with your kitty, provided that you will keep your kitty on **NuVet Plus**. With environmental issues and differences within each household and yard that can be the cause of so many allergies, viruses and bacteria in the air. Seller highly recommends buyer to continue to give your kitty NuVet Plus sprinkled daily on their food which is a powerful antioxidant that give a tremendous boost to the immune system to prevent problems and creates a defense against over fifty major diseases and extending the life span of your kitty.

The three year replacement guarantee will be honored as stated above. If kitty should be found to have a congenital defect or die within a three year period of purchase the seller will agree to replace the kitty, only if appropriate necropsy (autopsy) is performed by a qualified veterinarian at the purchaser's expense. A veterinarians certificate is required as proof that cause of death was a direct result of congenital defect.

Under no circumstances will the seller be responsible for any veterinary bills incurred by the purchaser.

Under NO circumstances shall this kitty be de-clawed.

The purchaser agrees that under NO circumstances will the kitty EVER be sold or given to a pet shop, animal shelter, research laboratory, or similar facility. Should the purchaser for any reason including death, not be able to keep the above kitty, the seller has the FIRST option to take/buy the kitty for the cost of shipping only.

All travel expenses and shipping will be paid by the purchaser. I do not ship by plane unless accompanied by their new adopted parents. I do except U-Ship for transportation of kitty. This is done by picking kitty up from my house and delivered to your house.

It is understood that with the Sphynx breed hairlessness will vary from kitty to kitty due to hormones, climate, and genetics. It is important for the purchaser to understand it is impossible to guarantee complete hairlessness for the life of the kitty. It is possible for the said kitty to develop some hair especially after being spayed/neutered or as it grows older. This hair is specific to the tail, feet and ears.

- Any legal action which may arise under the terms of this contract will be brought to Hickman County, Kentucky. The new owner shall be liable for all expenses in the amount of purchase of kitty, shipping expenses, associated veterinary expenses, costs resulting from litigating this contract, and any damages caused to the reputation of Abeitagatos Cattery. This document is a legally binding contract. In signing this document the new owner acknowledges he/she read and fully understands and agrees to ALL of the terms and conditions stated above. The laws of the state of Kentucky shall be controlling.
